GENERAL INFORMATION

Lake Springfield Park & Grounds (including Tailwaters, Southwood and Henshaw) are operated by the Springfield-Greene County Park Board (SGCPB). Limited hunting is managed by the Missouri Dept. of Conservation, (417) 895-6880. Valley Water Mill park is operated by the Springfield-Greene County Park Board and Watershed Committee. Park areas are open sunrise to sunset. All visitors must exit the park at sunset. Pets must be on a leash in all park areas.
