## GENERAL INFORMATION

Lake Springfield Park & Grounds (including Tailwaters, Southwood and Henshaw) are operated by the Springfield-Greene County Park Board. (SGCPB)

Lake Springfield water (Kinser Bridge to the Dam) is controlled by City Utilities, 831-8595.

Hunting is coordinated by the Missouri Dept. of Conservation, 895-6880.

Valley Water Mill Park is operated by the Watershed Committee and Springfield-Greene County Park Bd.

Park areas are open sunrise to sunset.

Boats must be off of Fellows Lake at sunset.

Pets must be on a leash in all park areas.
