Rate Reduction Provision

Effective Cycle 1, August 2036, the customer charge shall be reduced by \$1.25, the demand charge for the first 900 kWh used October through May shall be reduced by \$0.0113 per kWh, the demand charge for additional kWh October through May shall be reduced by \$0.0102 per kWh, the demand charge for the first 500 kWh June through September shall be reduced by \$0.0113 per kWh, and the demand charge for additional kWh June through September shall be reduced by \$0.0102 per kWh.
