CITY UTILITIES OF SPRINGFIELD MISSOURI OPTIONAL RIDER G SOLAR ENERGY

Applicability

Under this Rider G, City Utilities will provide energy and the option to receive Solar Renewable Energy Credits sourced from the City Utilities Solar Farm (CUSF). Energy amounts are variable each month, and are determined through a defined allocation of monthly production from the City Utilities Solar Farm, as reported by City Utilities using conventional energy accounting methods.

Availability

Service under this rider shall be available within the corporate limits of the City of Springfield, Missouri, and the adjacent territory served by City Utilities by the Residential Electric Service Rate, General Lighting Service Rate, General Power Service Rate, Large General Power Service Rate, and Large Power Service Rate, by special contract. This Rider is subject to the availability of energy from the CUSF, which is limited by available capacity from the CUSF, the variable production of energy from the CUSF, and by programmatic limitations specified by the Board of Public Utilities. Availability is subject to the General Terms and Conditions Governing Electric Service and the Utility Service Rules and Regulations.

Charges under this rider represent the additional cost of energy beyond usual energy costs associated with City Utilities electric rates, and shall be in addition to charges for service under other applicable rates. In order to represent the fixed, long-term nature, of the purchased energy contract associated with the CUSF, charges created by this rider adjust coincident with the fuel adjustment factor to net to a fixed fuel adjustment of \$0.0404 per kWh of allocated energy from the CUSF.

City Utilities may, in certain circumstances, transfer to the customer the Solar Renewable Energy Credits produced by the customer's allocated portion of energy provided through this rider. Solar Renewable Energy Credits, otherwise assignable to customers through this rider, but not transferred to the customer, will be retired. Additional costs payable to any party other than City Utilities to account for and to enable customer's credit transfer or retirement may be charged to the customer, at the option of City Utilities.

A customer selecting this rate option agrees to continue service under this rider for a period not less than two years. Termination of service, through the selection of the customer, prior to the end of the required minimum two year period will result in a termination fee of \$100 to be applied to the customer's account.

Outside City Charge

All charges shall be five (5) percent more per service outside the corporate limits of the City of Springfield, Missouri.
