## Guidelines

1. **Application must be submitted within 90 days of purchase date.**
2. City Utilities residential and commercial water customers are eligible for a rebate of 50% of the toilet purchase price up to \$75, after the purchase and installation of a WaterSense® labeled High Efficiency Toilet. Rebate will not exceed purchase price.
3. **Residential customers may receive up to three (3) rebates per service address. Commercial customers may receive up to six (6) rebates per service address.**
4. Additional rebates may be considered for larger multi-family or commercial projects on a case by case basis. Please contact City Utilities prior to submitting an application.
5. A completed WaterSense® High Efficiency Toilet Rebate Application is required. The application must include the manufacturer and model number of the toilet purchased.
6. Customer must submit a dated, detailed sales receipt as proof of purchase. If the toilet is installed by a contractor, **the purchase price of the toilet must be clearly itemized on the invoice.**
7. Ultra low-flow toilets and any non-WaterSense® labeled toilets do not qualify.
8. New construction qualifies for the rebate.
9. Toilet purchase must include both bowl and tank, and be installed at the service address listed on the application.
10. Applicant must be the customer of record for an active, non-delinquent account.
11. Old toilets must not be reused. Participants agree to destroy or disable their old toilets, and dispose of property. City Utilities encourages recycling, if possible.
12. Failure to provide required information may result in denial of the rebate.
13. Rebates are awarded on a first-come, first-served basis until program funds have been depleted.
14. City Utilities reserves the right to inspect the installed rebated material. If such site does not have the qualifying equipment installed, the amount rebated may be debited back to the account.
15. City Utilities is not responsible for equipment performance or water savings, and does not provide any warranties or guarantees, expressed or implied.
16. **City Utilities reserves the right to amend or discontinue this program without notice.**
